Essential Board Information

Title of Board:	The Parole Board
Department with Responsibility:	Justice and Equality
Board Category / Fees:	<p>As per Category 3 of Fees Payable on State Bodies the Chairperson is paid a fee of €11,970 per annum.</p> <p>Ordinary Board Members are paid a fee of €7,695 per annum.</p> <p>In addition to the annual fee, the Chairperson and Board Members are paid a per diem fee of €149.75 per prison visit for conducting prisoner interviews (to a maximum of €12,600 per annum) plus travel and subsistence in line with Civil Service regulations</p>
Board Meeting Location:	The Parole Board, 2 nd Floor, 6/7 Hanover Street, Dublin 2
Meeting Frequency:	Members are expected to participate at monthly Board meetings. Members must also be available to visit any of the 14 penal institutions within the State on at least one day a month, possibly two days, to interview prisoners as part of the parole review process. In 2015, 94 prisoners were interviewed by the Parole Board.
Purpose of the Board:	<p>The Parole Board is a non-statutory body which advises the Minister for Justice and Equality on the management of those serving long term prison sentences.</p> <p>It was established on an administrative basis in April 2001 replacing the then Sentence Review Group. The Board has a Secretariat to assist in its work.</p> <p>The Board reviews the cases of prisoners sentenced to determinate sentences of eight years or more and life sentenced prisoners after seven years.</p> <p>When formulating its recommendations, the Board is primarily concerned with the risk to the public that the prisoner may pose. The main factors taken into account in each individual case are:</p> <ul style="list-style-type: none">• the nature and gravity of the offence;• sentence being served and any recommendations made by the Judge;• period of the sentence served at the time of the review;• previous convictions and history of offending behaviour;• threat to safety of members of the community from release;

- risk of further offences being committed while on temporary release;
- risk of the prisoner failing to return to custody from any period of temporary release;
- risk of non compliance with conditions attached to parole;
- conduct while in custody;
- extent of engagement with the therapeutic services, and
- likelihood of period of temporary release enhancing reintegration prospects.

Following a review, the Parole Board, by way of recommendation, advises the Minister of the prisoner's progress to date, the degree to which the prisoner has engaged with the various therapeutic services, the steps he/she has taken to address the nature of their criminal offending, and how best to proceed with the future management of the prison sentence.

The final decision on the recommendations of the Parole Board is made by the Minister.

Prospective candidates should note that there are legislative proposals to establish the Parole Board on an independent statutory basis.

Vacancy Details

The Board, which comprises 11 members and a Chairperson, represents a diverse range of backgrounds, experience and expertise. As explained below, the Chairperson will have a legal background. The Board must also include a psychiatric professional.

Other than the ex-officio members, the membership of the Board will represent community interests generally and may include persons with experience of medical, legal, psychology, psychiatry, education, policing, prisons and probation matters relevant to the criminal justice area.

There is currently one vacancy. A further vacancy will arise in February 2017, which will be filled by a psychiatric professional, and three further vacancies will arise in July 2017, including the position of the Chairperson. Members serve in a part-time capacity. The term of appointment is for three years. Members may be re-appointed by the Minister for another term in accordance with the Department of Public Expenditure and Reform Guidelines on Appointments to State Boards; <http://www.per.gov.ie/en/appointments-to-state-boards/>

Applicants applying for the position of Chairperson should indicate if they wish to be considered for an appointment as an ordinary Board member in the alternative.

Skills Desired / Essential Criteria

Expressions of interest in serving as a member are sought from suitable persons with competence, experience and an interest in this area. Candidates must be of good character and will be subject to Garda vetting prior to appointment.

Candidates will be required to contribute effectively to the work of the Parole Board. This will involve the ability to collaborate and work effectively and cohesively as a member of the Board.

Candidates should possess:

- Excellent judgement and analytical skills with the proven capacity for independent assessment of complex issues and decision making;
- Excellent communication and interpersonal skills;
- Knowledge of the wider societal issues impacting on the criminal justice environment including those in relation to the rehabilitation of offenders and victim's rights;
- Ability to work effectively as part of a team;
- Relevant professional experience.

Candidates applying for the position of Chairperson should also possess:

- Legal qualifications including but not limited to being a practising Solicitor or Barrister or retired Judge
- Excellent organisational, management and leadership skills.

Confidentiality at all times is a key requirement. Suitable candidates must be discreet in managing highly sensitive, personal, and confidential information. It is expected that members would communicate issues of concern via the Parole Board and would not engage in public discussions regarding individual cases.

Candidates must also be adaptable and flexible. Members of the Board are required to devote at least two days per month (one for the Parole Board meeting and one for interviews with prisoners/applicants) to the role and may be required for more depending on the number of interviews to be carried out.

Application & Assessment Process:

If you are interested in being considered for appointment to the Parole Board, you should submit an 'Expression of Interest' (EOI) to paroleboardapplication@justice.ie

The 'Expression of Interest' will consist of a comprehensive Curriculum Vitae along with a covering letter (no more than two pages) outlining your achievements and experience, and the relevance of your expertise to the work of the Parole Board.

The completed EOI will be assessed by a panel consisting of:

1. A representative from the Prisons Policy Division, Department of Justice & Equality
2. A representative from the Human Resources Division, Department of Justice & Equality
3. An independent member

The assessment panel will review the EOIs and submit those deemed to have met the required standard to the Minister for Justice and Equality for review. Interviews will not be carried out unless in circumstances where the panel deem it necessary.

The Department will contact you once the Minister has made her final decision.

Orientation will be provided to new Board members.
